**MINUTES OF THE STATE INDEMNITY SUB-COMMITTEE (SISC) MEGHALAYA, SHILLONG
HELD ON THE 24TH OCTOBER 2017 AT 2:00 PM**

The meeting was presided by Dr(Mrs).B. Mawthoh, Director of Health Services (MCH&FW), Cum Jt. Mission Director, NHM, Meghalaya, Shillong who welcomed all the members attending the meeting. The State Nodal Officer presented five cases to the Jt. Mission Director, NHM and to all the members. From East Khasi Hills District two cases, one death following sterilization & one failure following sterilization. From West Khasi Hills District, one case of failure following sterilization, from Ri Bhoi District two cases of failure following sterilization. The relevant documents were scrutinized by the members of the Sub-Committee.

The Committee has rejected one case from West Khasi Hills District which is failure following sterilization as documents are not complete and there is no uniformity in the name and title of the beneficiary.
